First, is the First Edition of our *50 State Survey: Requirements to Communicate with Insureds for Property and Casualty Claims*, authored by the firm's global Insurance Services Practice Group. This book, the Sixth Volume of Hinshaw's *On The Law* series, provides a 50 state overview for claims professionals of the statutes and regulations that apply in each state to first-party and third-party claims, as they relate to the specific timing of (1) an insurer's initial response to a notice of claim and to other communications from an insured; and (2) provision of a coverage position or reservation of rights to the insured. Second, a new commentary "*Key U.S. Insurance Decisions, Trends, & Developments: In These Times Of ESG, Social Inflation, COVID-19, Cyber/Privacy, Civil Unrest, Opioids & Other Perils*" was published in multiple Mealey's reports in December and will be published in additional reports in January. Scott Seaman and Sarah Anderson look back at some of the key decisions, trends, and developments impacting the U.S. insurance industry over the past couple of years. They also look ahead to what the new year promises. The authors discuss, that while COVID-19 continues to rage in 2021, ESG/sustainability has taken the spotlight for insurers and reinsurers. They also review developments involving social inflation, COVID-19 business interruption, cyber/privacy, civil unrest, opioids, lead, construction defect, and securities law, among other issues. We will issue a separate press release in the coming days. This marks the twenty-first consecutive year in which the treatise has been updated. Key updates were made to the chapters on defense costs and attorney fees, D&O liability insurance, cybersecurity and privacy claims, social inflation, and COVID-19. A new section on ESG/Sustainability was added in this edition along with a new chapter on representations and warranties insurance.

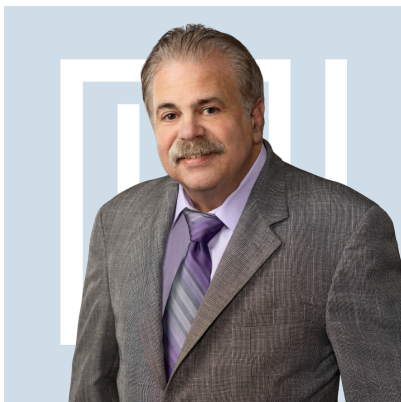
