It notes how Hinshaw partner Matthew Walsh II followed his father Matthew P. Walsh, Sr. (Matt the Elder) into the legal profession, served as President of the Celtic Legal Society of Chicago, and attended Ireland's State Dinner at the White House as the guest of then Taoiseach Enda Kenny in 2017.
