Carlisle Advocacy Award from Legal Aid of Broward County](#) which is given annually to an advocate whose actions exemplify a personal and professional commitment to making justice available to the poor and disadvantaged. La Chuisa was specifically recognized for her participation in and leadership of 17 Hinshaw Fort Lauderdale attorneys who volunteered for a total of 178 hours in 2024 and 2023 for the Broward Lawyers Care Legal Aid Hotline and the Florida Rights Restoration Coalition.

In addition, Hinshaw's Fort Lauderdale office was named the 2024 Legal Aid of Broward County Law Firm of the Year which is presented annually to a firm that has shown its overall commitment to the organization's work and

the clients it serves.
