Experience

- Defended a pension actuary before the US District Court for the Northern District of Illinois brought by the trustee of a defined benefit pension plan alleging that the actuary participated in a prohibited transaction with a company insider and seeking money damages and disgorgement of fees under ERISA. On the facts alleged, the district court dismissed all claims against the actuary.
- Defended a Fortune 500 services company before the US District Court for the Eastern District of New York, alleging a wrongful denial of life insurance benefits. On a motion to dismiss, the federal court dismissed all claims against the firm's client with prejudice before the commencement of discovery.
- Defended a pension actuary before the US District Court for the Northern District of Illinois in a suit alleging that the actuary was a fiduciary under ERISA who breached statutory duties to a defined benefit pension plan. The federal court rejected the allegation that the actuary was a fiduciary under ERISA as implausible and dismissed all the claims against the actuary.
- Secured a favorable outcome for an individual business owner in a case involving a Taft-Hartley pension fund that sought personal liability for millions in unpaid pension withdrawal liability. Following discovery, the pension fund conceded the majority of its claim.
- Represented an individual investor before the US Court of Federal Claims challenging the government's position regarding the timing of the deductibility of a theft loss resulting from the client falling victim to a fraudulent investment scheme that received national notoriety. Following discovery, the case was successfully mediated by a federal judge.
- Secured a favorable outcome for a widow before the US Merit Systems Protection Board, leading to the restoration of her survivor's pension and the commencement of future payments. The US Office of Personnel Management fully conceded its position, paid back pension amounts, and awarded attorney's fees to the client.
- Defended a Fortune 100 retail company in a case before the US District Court for the Northern District of Illinois, alleging a wrongful denial of medical benefits and COBRA continuation coverage. Following the completion of discovery, the court entered summary judgment in favor of the firm's client.
- Represented a closely held corporation before the Illinois Department of Revenue Administrative Hearings Division following a grand jury investigation. On a motion following the discovery of the state's abuse of grand jury secrecy, the administrative law judge removed the state's lead lawyer from the case and suppressed critical parts of the state's evidence.
- Represented a corporate officer before the Illinois Department of Revenue Administrative Hearings Division in a case alleging a failure to ensure that corporate sales and use taxes be paid and personal liability for the taxes, penalties, and interest. After a trial, the administrative law judge found in favor of the officer.
- Defended a corporate officer in the US District Court for the Northern District of Illinois against a claim of personal liability for federal employment taxes. After the government fully conceded the merits of its claim, the federal court ordered an award of attorneys' fees against the government and in favor of the corporate officer.
