• In May 2025, a unanimous defense verdict was secured in an insurance bad faith case against an international insurer, venued in the Central District of California Federal Court.

- Obtained a unanimous jury defense verdict in an insurance bad faith case arising from a California wildfire loss, venued in the Northern District of California Federal Court in February 2025.
