Patent Prosecution: Roger has written and prosecuted patent applications in the United States, China, Europe, and Japan, covering alarm systems, cloud operating systems, data mining, dispensing, food and chemical processing, food products, fraud prevention, night vision, ophthalmic solutions, orthoses, and restaurant equipment.

IP Dispute Resolution: Roger represents clients in litigation and arbitration involving patents, trade secrets, copyrights, and trademarks, as well as sending and responding to cease-and-desist letters. Disputes have included chemical processing equipment, consumer goods, contact lenses, food, golf clubs, insurance, night vision equipment, specialty chemicals, and telephony.

# **Experience**

- Successfully defended a confectionary manufacturer in a patent and trade dress dispute, resulting in no liability being established on summary judgment.
- Established client patent program, including educating potential inventors on patent law and invention disclosure forms for patentability searching and patent filings. Seven patent applications have been filed, three of which have been issued as patents, with the others pending.
- Successfully prosecuted patents for a natural food product for a Fortune 100 company. Highlights included defeating a post-grant opposition proceeding before the EPO and overcoming rejection by the Venezuelan patent office by writing arguments partially in Spanish, referencing the specific wording of substantive Venezuelan patent law.
- Devised an IP strategy for US manufacturer expanding to India with a new product line in R&D. In particular, (1) patent searching identified no blocking patents to the product line, (2) international trademark applications designating India have been filed, and (3) an international patent application for the product line has been filed.
- Successfully had two patent trolls dismiss their software patent lawsuits without any settlement. In the first lawsuit, effectively filed a motion to dismiss based on the asserted patent being abstract. In the second lawsuit, successfully threatened to file a motion to dismiss based on the asserted patent being abstract and a lack of factual allegations of infringement.
- Successfully prosecuted patents in the United States and the European Patent Office (EPO) for a solo inventor, obtaining broad coverage in the material sciences. The EPO successfully overcame a unity of invention rejection, allowing broad coverage to be achieved in a single patent.
- Successfully drafted and prosecuted patents for a user interface for restaurant equipment for a Fortune 150 company in the United States, Australia, Canada, China, and Japan.
- Negotiated a favorable settlement prior to filing an answer, as statutory damages were unavailable to the photographer plaintiff because the client's use of a photo began after the photo was published and before the effective date of the copyright registration.
- As second chair, achieved a multimillion-dollar award for breach of a patent license relating to optics in a complex International Chamber of Commerce arbitration seated in London between an American licensor client and a French defense contractor.
- Discovered massive spoliation of evidence in trade secrets civil litigation relating to fine chemicals. This discovery culminated in the defendant pleading guilty to four criminal counts of unauthorized possession of stolen trade secrets and agreeing to a permanent injunction and a multimillion-dollar judgment for our client.
