Experience

- Represented a national bank in a case of first impression, wherein the Court of Appeals (New York's highest court) held that the automatic bankruptcy stay caused by a bankruptcy filing is a valid "statutory prohibition" under New York law CPLR sec. 204. Accordingly, the Court determined that the statute of limitations for commencement of an action was tolled and rejected the borrower's appeal of the denial of his motion to dismiss which had been issued by the trial court and upheld by the intermediate appellate court. The case has wide-ranging implications for all cases where there has been an intervening bankruptcy.
