Experience

• Defended two corporations in the US District Court trials and related US Court of Appeals for the Eighth Circuit proceedings against a Department of Justice (DOJ) led, multi-seven-figure civil penalty and cost recovery action from 2013 to 2020. The cases involved numerous experts, corporate and fact witnesses, and substantial motion practice.

- Successfully reduced a major paint manufacturer's initial CERCLA liability allocation, as calculated by the US
 EPA, from a significant share to zero. This outcome was achieved through strategic cross-examination of the
 Milwaukee-area drum reclaimer facility manager and multiple Chicago route truck drivers, effectively
 discrediting the evidence linking the client to the contamination site and demonstrating the absence of any
 direct contribution to the hazardous waste disposal.
- Successfully defended a paint manufacturer in a toxic tort suit at a CERCLA site, resulting in a nuisance-value settlement in the Milwaukee area.
- Represented a major automotive systems manufacturer in central New York State, reducing the client's share
 of CERCLA costs from a high six-figure demand to an early de minimis cash-out by privately interviewing the
 owner of a 1970s waste oil reclaiming company.
- Led the defense of 18 mass toxic tort actions arising from PCB exposure at a transformer manufacturing facility
 in central Mississippi, reducing litigation risk for a manufacturer and its former corporate parent. The cases,
 filed in multiple state and federal jurisdictions, involved over 1,200 plaintiffs alleging personal injury, property
 damage, and diminished property value. Oversaw strategy and trial preparation, including removal practice,
 dispositive motions, Daubert challenges, and the presentation and cross-examination of more than 30 expert
 witnesses.
- Negotiated a settlement with zero penalty and reduced remedial action scope and cost in response to a sevenfigure RCRA penalty groundwater enforcement demand on behalf of an Alabama-based aircraft refurbisher and government contractor.
- Represented a major automotive component systems manufacturer and negotiated within the existing PRP
 Group to reduce the client's participation share by two-thirds without invoking formal group-wide allocation
 procedures.
- Boldly opted out of de minimis settlement at a potential \$100+ million Superfund site, ultimately reducing the client's cost by more than 90 percent and deferring assessments.
- Served as criminal enforcement and environmental counsel to a prominent white-collar crime legal team
 defending the plant manager of an Indianapolis, Indiana battery reclaiming facility, among others. Involved in
 preparing defense expert opinion disclosures and testimony, cross-examining US government expert
 witnesses, and briefing Clean Water Act legal issues.
- Served as common litigation counsel charged with identifying and adding third-party defendants and litigating substantial contribution claims while also defending major paint manufacturers in United States' CERCLA cost recovery action.

- Represented a heavy equipment manufacturer in a Resource Conservation and Recovery Act (RCRA) citizen suit concerning underground storage tanks and associated environmental impacts. Through strategic motion practice, achieved removal of the tanks and negotiated a minimal settlement, effectively mitigating potential liabilities and ensuring compliance.
- Negotiated a favorable remedy and funded much of the site work by cashing out smaller parties while managing the PRP group's remedy and regulatory engagement with the Illinois EPA at an Illinois Superfund site.
