# **Experience**

- Obtained summary judgment and affirmed on appeal in defense of contested foreclosure action in which borrower challenged the authority of the foreclosing mortgagee based on claims of fraud, invalid assignment of mortgage, and improper foreclosure.
- Obtained summary judgment in defense of a contested foreclosure action in the which borrower alleged deficiencies in notice of default as condition precedent to foreclosure.
- Obtained a dismissal of claims against a lender by bankrupt debtor asserting lack of standing and asserting rights under pooling and servicing agreement.
- Successfully defended a lender's interests following a foreclosure deed in tax petition dispute.
- Successfully defended a lender in dispute with condominium association on liability for outstanding assessments following foreclosure.
- Assisted a pro se criminal defendant and argued before the US Court of Appeals for the Seventh Circuit in a case involving allegations of mail fraud and arson.
- Secured an arbitration award for a financial institution before the American Arbitration Association (AAA) involving claims of breach of contracts, common law negligence, violation of the Electronic Funds Transfer Act (EFTA), Delaware Uniform Commercial Code Article 4A (UCC), and Delaware Consumer Fraud Act (CFA), the Delaware Identity Theft and Breach of Security Monitoring Act (Identity Theft Act), the Delaware Banking Code, and the Gramm-Leach-Bliley Act (GLBA). Hinshaw's legal team convinced the arbitrator to issue an arbitral award dismissing all the claims with prejudice against the claimant.
- Secured an appellate victory on behalf of a financial institution in a case involving claims of breach of contract, conversion, and unjust enrichment. Hinshaw successfully convinced the court to dismiss the case for lack of jurisdiction.
- Successfully secured a motion to dismiss on behalf of a financial services client in an alleged race discrimination case. The court found that bank holding companies are not liable for alleged misconduct by one of their subsidiaries.
