Experience

- Successfully achieved the dismissal with prejudice of a malpractice lawsuit against a dentist and their dental practice on the eve of jury selection and opening statements. Despite an attempt by the plaintiff to settle pretrial, the defense team's readiness to proceed to trial led to the patient voluntarily withdrawing the lawsuit altogether on the morning of the trial following aggressive pretrial motion practice, ending the lawsuit permanently.
- Obtained[DM1] a defense verdict for two nephrologists in a wrongful death/medical negligence case after a two-week trial after the co-defendant hospital settled out. Plaintiff asked for \$2.25 million, and the jury returned a defense verdict as to both doctors in under 10 minutes.
- Obtained a not-guilty verdict following a bench trial. Hinshaw represented a US Army Veteran employee of EMT business client who was charged with criminal violations of conceal and carry gun charges.
- Obtained a dismissal with prejudice after plaintiff untimely filed his chiropractic malpractice case in violation of the applicable statute of limitations.
