Experience

- Prevailed in restoring water rates to historical levels for a senior living facility after successfully arguing that an Arizona Domestic Water Improvement District's rate increase violated the Fair Housing Act (FHA), Arizona State Fair Housing Act (AZFHA), and the Americans with Disabilities Act (ADA).
- Prevailed at the Arizona Supreme Court, establishing a legal precedent in property law by securing recognition of a cause of action for a boundary by acquiescence and setting the elements of proof for such a claim.
- Defended a full-service real estate brokerage and its agent in a malpractice case involving claims of non-disclosure and misrepresentation, resulting in a complete victory through summary judgment, with all claims dismissed. The plaintiff had sought \$500,000 in damages.
- Defended a nonprofit foster care organization against allegations of negligence, breach of contract, and sexual abuse, ultimately prevailing on all claims and avoiding \$50 million in potential damages.
