In addition, the parties disputed entitlement to fees and costs. The court ultimately granted QBE entitlement to attorneys' fees and taxable costs pursuant to applicable state and federal laws.
- Obtained summary judgment on behalf of Scottsdale Insurance Co. based upon the insured's failure to comply with several policy conditions, such as providing prompt notice, failing to keep an accurate record of repairs and expenses, failing to show the damages property, and failing to provide records upon request. In addition, the parties disputed entitlement to fees and costs. The court ultimately granted Scottsdale's entitlement to attorneys' fees and costs pursuant to Florida law.
