### **About Danielle**

Danielle defends local government entities and employees in 42 U.S.C. § 1983 civil rights claims, including Fourteenth Amendment substantive and procedural due process allegations such as state-created danger, excessive force, wrongful incarceration, wrongful prosecution, failure to provide medical care in custody, retaliation, wrongful search or seizure, and more. She also defends clients against Illinois state law claims, primarily focusing on wrongful death, survival actions, negligence, medical malpractice, and breach of contract claims.

In addition, Danielle prosecutes evidentiary hearings before the Chicago Police Board, representing the superintendent of the Chicago Police Department in cases seeking termination of police officers for misconduct. Understanding the stress and sensitivity associated with being sued, Danielle maintains personable relationships with her clients while rigorously advocating for them throughout the litigation process.

Danielle is co-chair of Hinshaw's Mediterranean Plus Affinity Network. Prior to joining the firm, she served for four years as an Assistant State's Attorney of Cook County in the Civil Actions Bureau, Civil Rights and Torts Unit. She defended Cook County employees and the county against individual claims, class actions, and in the US Court of Appeals for the Seventh Circuit involving Section 1983 civil rights violations, as well as state law claims of personal injury, premises liability, and wrongful death.

While in law school, Danielle externed for the Honorable Matthew F. Kennelly in the US District Court for the Northern District of Illinois, Eastern Division. She clerked in the Special Prosecutions Bureau and Civil Actions Bureau of the Cook County State's Attorney's Office. With her 711 license, she conducted several bench trials in the Seniors & Persons with Disabilities Unit and the Traffic Unit and actively participated in court appearances and motion practice in the Conflicts Unit.

- Obtained a defense verdict in Cook County Circuit Court on behalf of the Cook County sheriff in a wrongful death jury trial involving allegations of neglect of a jail detainee. The plaintiff sought more than \$2.3 million in damages.

- Obtained summary judgment in a motor vehicle accident suit involving three separate parties and a counterclaim.
- Obtained prosecution verdict in a petition for court order of detention and examination involving a mentally ill individual at risk of serious physical harm to themselves or others.
